

**POOL WAIVER AND RELEASE OF LIABILITY  
WAIVER OF CLAIMS, ASSUMPTION OF RISKS, AND INDEMNITY AGREEMENT**

**PLEASE READ CAREFULLY  
BY SIGNING THIS DOCUMENT, YOU CHOOSE TO WAIVE  
CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.**

I, the applicant signing below, wish, both for myself and my child, if applicable, to swim and utilize the swimming pool facilities operated by Meadow Lakes Golf Course, 383 Adams Road, Cedartown, GA. I recognize and fully understand certain things including:

- There will be no lifeguard on duty during business hours and after close of business.
- My use of pool facilities, either for myself, children or guest, if applicable, at Meadow Lakes Golf Course involves certain risks including: The risk of injury resulting from possible malfunction of the pool equipment; the result of injuries from tripping or falling over obstacles in the pool area; the risk of injuries resulting from unsupervised divers and swimmers colliding; the risk of other injuries from participating in swimming activities; the risk of injuries from possible reckless conduct of others at the pool.
- I recognize and fully understand that the above list is not a complete or exhaustive list of all possible risk; the list only provides examples of the types of risks I am assuming.

In exchange for Meadow Lakes Golf Course allowing me ,for myself or my child, if applicable, to utilize the swimming pool and appurtenances associated with the pool facilities, I hereby agree to the conditions below. It is my full intent and choice that I have declared by my signature to give up legal rights as stated below. I further agree to abide by rules and regulations which I have been made fully aware:

- TO WAIVE ANY AND ALL CLAIMS that I have or may have for myself or my child, if any, in the future against Meadow Lakes Golf Course, its owners, managers, employees, representatives, and/or guests (hereinafter referred to as the "Releasees") relating to my use of the swimming pool at Meadow Lakes Golf Course.
- TO RELEASE THE RELEASEES from any and all liability for loss, damage, injury, expense, or other costs that we may suffer or that my next of kin may suffer in connection with my use of the swimming pool at Meadow Lakes Golf Course due to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES.
- TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability to property of, or personal injury to, any third party, resulting from my use of the swimming pool at Meadow Lakes Golf Course.
- That I am over the age of 18 years old and that I am a member in good standing at Meadow Lakes Golf Course, 383 Adams Road, Cedartown, Georgia.
- All guests of Members using the pool must pay a fee of \$2.50 per day. All guests must be accompanied by the member.
- That this Waiver, Release, and Agreement is fully effective and shall be effective and binding upon me, my heirs, next of kin, executors, administrators, and assigns, or anyone else authorized to act on my behalf or on behalf of my estate.

**I have read and understood this document. I am aware that by signing this document, I am waiving certain legal rights that I may have now or in the future against the Releasees, and I fully agree to waive those rights.**

## **Meadow Lakes Pool Rules**

- No Lifeguard on Duty
- Children under the age of 14 must be accompanied by an adult.
- The pool facilities are for members and their guest. ( See Guest Policy below )
- All members and guests must sign in.
- The entire pool is non-smoking.
- Proper swim attire is required. No street clothes, denim shorts are permitted in the pool area.
- No pets allowed in pool area
- No running on pool deck.
- No pushing, excessive splashing, excessive horseplay, or inappropriate behavior.
- No Diving Allowed
- No food, gum, or Band-Aides permitted in pool.
- Children not toilet trained must wear swim diapers.
- Pool restrooms must be used for any clothing changes ( ALL ages ) and diaper changes.
- Individuals who can not swim are only permitted in the shallow end of the pool.
- Glass containers are prohibited in the pool area.
- Persons with open wounds, rashes, nasal discharge, inflamed eyes, or bandages are not allowed in the pool.
- Persons who appear to be under the influence of alcohol or drugs will not be permitted in the pool or in the surrounding area.
- The pool will be cleared for approximately 30 minutes in cases of bad weather, including lightening strikes, tornado warnings, ect.
- All members and guests using the Meadow Lakes pool must abide by all posted rules.
- Failure to do so can result in ejection from the pool and possible loss of membership privileges.
- No outside food or beverages allowed. Food (including snacks) and beverages may be purchased in the clubhouse. You may call 770-748-4942 to place an order and your order will be delivered to you.

### **\*\*Employee usage and Guest Policy\*\***

Employees may use the pool free of charge. All guest of Employees or guests of Members must pay a fee of \$2.50 per day. All guests using the pool must abide by the rules and regulations above and must be accompanied by the employee or member.

### **\*\*Pool Parties\*\***

There will be no exclusive parties. All non member guests for parties will pay \$2.50 each person.
